## **Seattle Lutheran High School Board of Directors**

The management of Seattle Lutheran High School is vested in a Board of Directors. Board members terms are from July 1 of the year in which they are elected to June 30 of the final year of their term(s). Board members are elected for three year terms, with up to two consecutive three year terms. Through attendance at monthly meetings, some of which may be held with the Board of Hope Lutheran School to review common budgetary and curriculum agendas, and through work on Board Committees and other activities, the function of the High School Board of Directors is to carry the ultimate responsibility for the management of the school in relation to 1) Philosophy of the school 2) Theology for the school) 3) Development and direction of the program 4) Business operations and finance.

Each Board Member should be aware and fully supportive of the ultimate Mission of Seattle Lutheran High School:

**Mission:** *Seattle Lutheran provides a Christ-centered & student focused environment that equips young people in their educational & spiritual journeys to be servant-leaders in the world.*

Board of Directors officers, President, Vice-President, Secretary, and Treasurer are elected by the Board to one year renewable terms.

Committees, as in the areas of Finance, Communication, Development, Policy Review, Strategic Plan, and Program are established by the Board, with appointments to these committees and of their chairpersons made by the Board President, from within the Board and beyond.

**With membership on the Board, individuals are expected to be regular in attendance at Board meetings, usually held monthly, to give financially and assist in development (fundraising) and student recruitment, to represent the school in the community and in their congregations, to be ready to serve on committees, and to be active participants in the activities conducted by the Board and the school.**

Seattle Lutheran is a Christian School, and as such, prayer and Biblical Scripture are regular parts of Board meetings and activities. Furthermore, Board members are to be committed to the school's mission, and as such are called to participate in the Christian atmosphere of the school, sharing and working together in the context of Christ-centered relationships.
